The beds are provided on a priority basis depending on the emergency condition of the patient on all days of the week.
(b)	Whether, it has been observed that there is lack of apathy on the part of the medical staff especially on these days, if so, the reasons therefor; and	In AllMS, Bhubaneswar, there is no lack of apathy on the part of the Medical Staff on any day.
