Dear Sir/Madam,

An evaluation of Pradhan Mantri Swasthya Suraksha Yojana has been got conducted by the Ministry through the Indian Institute of Public Administration (IIPA), which looked into functional and performance aspects of AIIMS and projects for upgradation of Govt. Medical Colleges (GMCs). The evaluation study covered the six functional new AIIMS at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur and Rishikesh, besides 8 GMCs upgradation projects. Based on findings of the evaluation, follow up action needs to be initiated immediately on following points :

- To prioritise and fill up of all vacant Speciality and Super Speciality positions in the Institute in a time-bound manner;
- Monitoring of Surgeries (Major and Minor) and diagnostic tests in all AIIMS on monthly basis and preparation of a monthly report. .
- As previously circulated, each AIIMS must identify a particular thematic area in which it would develop itself as a Centre of Excellence;
- Creation of Hub and Spoke model with adjoining District Hospital and Community Health Centre to provide specialist consultation to patients in District Hospitals and Community Health Centres through the use of e-sanjeevani OPD;
- Exploration of Corporate Social Responsibility (CSR) resources for establishing Dharmshalas (wherever they do not exist presently);
- Qualitative improvement of Hospital and Hostel canteens; and
- Conducting a minimum of 2 SFC meetings in a year to ensure that critical issues are resolved in timely manner.
- Deputy Directors (Admn.) should hold regular monthly meetings with Local Administration and Municipal Administration to address and resolve issues of the Institute relating to these entities.

2. I would request you to take immediate action on all the above points and apprise the Ministry about the action taken within two weeks.
