It is hereby once again reiterated for information of the general public that AIIMS, Bhubaneswar is an Institute of National Importance under the administrative control of the Govt. of India. All the activities, decision making are done through prescribed rules and regulations as applicable. It has been brought to our notice that some unscrupulous elements are resorting to illegal activities of promising jobs, contracts, shops etc. involving the name of AIIMS, Bhubaneswar and indulging in alleged corrupt practice. Therefore, the following are hereby informed to all concerned public about AIIMS, Bhubaneswar.

- 1- AIIMS, Bhubaneswar issues open advertisement in News Papers, Employment News about any selection of regular jobs besides publishing it in its official Website. Those who are eligible as per the advertised qualification, experiences etc. are called for Computer Based Test /Written Test/Interviews as applicable, then selection process are done by duly constituted selection committee. All these information are periodically posted in our Website. Therefore, appointments against any posts either on regular basis or contractual basis are to be made against an open advertisement published in the News Papers/Website and through an objective Selection process as per the relevant recruitment Rules.
- 2- AIIMS, Bhubaneswar has engaged some agencies through open tender to supply manpower in Security, Housekeeping and other services as per the requirement. Any person so engaged by these agencies will be the employees of the agencies and deployed in AIIMS, Bhubaneswar only for the period of duration of the contract with these agencies subject to the condition that they found fit to discharge the duties as per our requirement having requisite eligibility. AIIMS, Bhubaneswar is not having any employer and employee relationships with these outsourced employees. These engagements are only for specific time and AIIMS, Bhubaneswar does not have any liabilities other than compliances of the applicable Labour Law.

The agencies are having contractual obligation with AIIMS, Bhubaneswar not to charge any money from any candidates. They should possess applicable qualification, experiences as per the requirement of the AIIMS, Bhubaneswar and they will be withdrawn by the agency at any time when their performances are not found satisfactory by the AIIMS.

3- All the procurement activities, award of any contract, allotment of any shop etc. are done through Govt. E. Market/open tender as and when required strictly as per the rules. All these information are regularly posted in our Website and award of contract is done through a prescribed process as provided under the rules. AIIMS, Bhubaneswar has not authorized any one to work on these matters.

Therefore, all the concerned general public are hereby informed not to fall prey to any such promises of getting jobs, contracts, shops etc. in AIIMS, Bhubaneswar. They are advised to inform the police about any such illegal activities. In case, they find any regular staff, outsourced staffs through agencies, Contractor/ Agency or claiming their agent involved any such alleged false assurances, then such incident should be reported to AIIMS, Bhubaneswar besides reporting to the police. Any agencies/contractor or their staff making any such false promises should be reported immediately to AIIMS, Bhubaneswar with evidences if available. Further, all general public are advised not to fall for any such false promises involving AIIMS, Bhubaneswar.
