No such malpractices on appointment processes in AIIMS, Bhubaneswar has been detected. AIIMS, Bhubaneswar conducts all their selection processes on a transparent and objective manner strictly as per the rules.
(b)	The process of appointment in all categories in Regional AIIMS Centres: and	The appointment in all categories in AIIMS, Bhubaneswar is being made as per the relevant Recruitment Rules and Instructions of the Government of India from time to time.
