(a)	Whether the Government is aware that around 5,80,000 planned surgeries in various hospitals across the country were cancelled or delayed as a result of the Covid-19 pandemic as per the study published in the Bristish Journal of Surgery;	Yes, it is a fact that some of the planned surgeries at AIIMS, Bhubaneswar were cancelled or delayed as a result of COVID-19 pandemic. However, AIIMS, Bhubaneswar continues to perform surgeries for both COVID and Non-COVID cases in addition to emergency surgeries (both major & minor), which have been provided 24 x 7 since March 2020.
(b)	If so, the details thereof;	At AIIMS, Bhubaneswar, the total number of surgeries performed from March 2020 to August 2020 is 3610.
