(a)	Whether the quantum of medical waste is continuously increasing in the country;	The Quantum of Medical waste is gradually increasing in AIIMS, Bhubaneswar. Total Bio-medical Waste (BMW) generated by AIIMS Bhubaneswar is 30609 Bags (Red, Yellow, Blue, White) having 63337.471 kgs. Proper steps are being taken for disposal of the same as per BMW Management Guidelines.
(b)	if so the details of the steps being taken by the Government for the disposal of the said waste, State/UT wise;	Not Applicable.
(c)	whether Government has also taken cognizance of PPE kits, Sanitizers, Masks not being made as per the laid norms in this regard;	Not related to AIIMS, Bhubaneswar.
(d)	if so, details thereof, State/UT-wise along with the steps taken to prevent it;	Not related to AIIMS, Bhubaneswar.
(e)	Whether the disposal of medical waste collected is being done as per conventional methods, if so, the details thereof: and	The disposal of COVID -19 waste is made as per the Guidelines issued for COVID -19 waste Revision 4, Central Pollution Control Board (CPCB), Govt of India. Disposal of Non-COVID Biomedical Waste is done as per BMW Rules 2017, 2018, and 2019. Disposal of general waste from the hospital is being done as per SWM Rules 2016 through "M/s Jagruti" an agency authorized by Bhubaneswar Municipal Corporation, Govt of Odisha.

(f)	The modern techniques being used by the Government to dispose of medical waste?	The COVID -19 waste is disposed off as per BMW (Covid) Guidelines. The transportation is done in a dedicated e-vehicle labeled as COVID -19 isolation waste. The waste bags are weighed and labeled with Bar Coded stickers. The data is uploaded to the website of the Central Pollution Control Board through the official app. Any accident, leakage, etc. are reported immediately to the concerned authority of the State Pollution Control Board (SPCB). The same has been inspected by the SPCB officials during their visit to the institution.
