(a)	Whether the Government has assessed the quality of medical/diagnostic equipment used in Government hospitals and if so, the details of outcome of the assessment;	(i) All the required medical equipment of AIIMS, Bhubaneswar are being procured through open tender process as per the technical specifications received from the user Department with due vetting by the Technical Committee. (ii) All the equipments procured through e-tendering process are under 5years warranty followed by 5yrs. CMC. (ii) Equipment worth Rs.30.00 lakh or more are being procured on the recommendation of the Technical Committee which included one External Expert who is also a member of the Technical Committee.
(b)	Whether most of the medical/diagnostic equipment used in All India Institute of Medical Sciences (AIIMS) and other leading Government hospitals are not of international standards, if so, the details thereof alongwith the reaction of the Government thereto;	AIIMS, Bhubaneswar procures only standard equipments through Tender process as per the technical specifications received from the user Departments.
(c)	The details of amount spent on the purchase of new medical/diagnostic equipment during the last three years by AIIMS, Institution-wise;	Details of Medical/Diagnostic Equipment procured from 02.04.2017 to 07.01.2021 are stated in Annexure-I. and Procurement made through Gem from 13.06.2019 to 28.08.2020 are stated in Annexure-II.
