### Terms and Conditions

- (1) All works of the project will be done as per the standard research protocol of the involved institutes.
- (2) The duration of project will be within the mentioned time period, unless the project is extended by mutual agreement between both the parties.
- (3) Both parties will contribute to the research work, as per their expertise, within the scope mentioned in the agreement, and any amendment of work pertinent to the project outside the mentioned scope has to be agreed by both parties.
- (4) The researchers will generally keep one another informed of the results of the work performed in connection with the Research Program, principally through their respective Principal Investigators.
- (5) Each party must maintain the confidentiality of the intellectual information derived from the project, from releasing to any other party, news media, scientific sessions, journal for publication etc. without each other's consent.
- (6) Both parties should maintain the proper documentation of the work including approval, Procedures, expenses and result of the work.
- (7) The approval from the Health Ministry Screening Committee (HMSC) Govt. Of India should be obtained for multinational studies, wherever necessary.
- (8) Material exchange in the form of experimental material or any biological sample has to be agreed by both parties.
- (9) Both parties has to comply the queries or concerns raised by the collaborative research committee of AIIMS, Bhubaneswar.
- (10) Institute Ethics Committee has the power to intervene at any stage regarding the study.
- (11) This agreement will be subject to compliance of all applicable rules and regulations of Government of India.
- (12) Neither party be involved in advertising any products, publicity, and promotion of materials to be disseminated to the public, or use any trademark, logo, or symbol of either institute or organization.
