- 2. The above vacancies are provisional and subject to variation. The Director, AIIMS, Bhubaneswar reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India Rules/Circulars and requirements or otherwise.
- 3. 4% of the total vacancies is horizontally reserved for PwBD (OH-OL and BL) candidates and also PwBD as per the Ministry of Social Justice and Empowerment's Notification No. 16-15/2010-DD.III dated 29th July, 2013 as amended from time to time as applicable. In case suitable Economically Weaker Sections (EWSs) candidates are not found, these posts will not be carried forward/or considered as backlog vacancy, hence Unreserved (UR) candidates may also be allowed provisionally to apply against EWSs posts advertised through above referred advertisement who may be considered incase suitable EWSs candidate are not found to fill up these posts reserved for EWSs.

**Professor/Additional Professor:** - Not exceeding 58 (Fifty-Eight) years as on the last date of the receipt of the online application i.e. 30 days from the date of the publication of this advertisement in Employment News/Rojgar Samachar.

**Associate Professor/ Assistant Professor:** - Not exceeding 50 (Fifty) years as on the last date of the receipt of the online application i.e. 30 days from the date of the publication of this advertisement in Employment News/Rojgar Samachar.

Age relaxation to other categories of the candidates will also be applicable as per the DoPT instructions. However, age relaxation will be regulated as per the DoPT instructions.

- 11. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/PwBD (OH-OL & BL)/EWS will be considered subject to Caste/PwBD Certificate issued by the appropriate/Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate.
- 12. Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non- creamy layer) in the prescribed form issued by Competent Authority. The certificate should be of the current financial year, in accordance with instructions issued by the Government of India in this respect from time to time. Applicants should ascertain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes. - 14. The candidates are to satisfy all eligibility criteria before online application. They must possess the educational qualification and experiences as recognised by the Govt. of India. The equivalent qualification such as MCH in Head & Neck Surgery as equivalent to MCH in Surgical Oncology and MCH in Hepato-Pancreatico-Biliary Surgery as equivalent to MCH in Surgical Gastroenterology and other similar such qualification will be decided by the Competent Authority of AIIMS, Bhubaneswar and his/her decision in this regard will be final.
- 16. Short Listing/Methods of the Selection: The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview or for selection. Based on bio-data, the Screening Committee may short-list candidates for interview.
