- 4. Those candidates who want to appear for interview physically must bring all original documents in support of their eligibility for the above post as well as other documents requested as per the Advertisement no. AIIMS/BBSR/RECT/DEPUTATION/2020/852/391 dated 23.05.2020
- 5. Candidates will have to produce the original documents at the time of joining, failing which their candidature will be cancelled.
