- 1. All the posts carry usual allowances as admissible to Central Government Employees of similar status at Guwahati(Assam).
- 2. The aspiring applicants satisfying the eligibility criteria in all respects can submit their application online in the prescribed format attached herewith along with self-attested copies of certificates/documents in support of fulfilling the essential criteria of age, educational qualification, teaching/research experiences etc.
- 3. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria up to the date of publishing this notification in Institute website i.e., https://aiimsbhubaneswar.nic.in failing which their application will be rejected.

# 4. Pay Scale: -

Level 11 of the Pay Matrix of 7<sup>th</sup> CPC (pre-revised pay band-3, Rs 15,600/- + 6,600/- GP) with entry pay of Rs. 67,700/- per month plus usual allowance as admissible. Allowance and perks will be admissible as per the rules besides Pay & NPA.

# 5. Maximum Age-limit: -

Senior Resident: - Not exceeding 45 (Forty-five) years as on the date of publishing of this notification in the Institute website.

- (i) Upper age limit shall be determined as on the date of publishing this notification in the Institute website.
- (ii) No age relaxation would be available to SC/ST/OBC Candidates applying for unreserved vacancies.
- 6. Age relaxation to other categories of the candidates will also be applicable as per the DoPT instructions. However, age relaxation will be regulated as per the DoPT instructions.
- 7. The candidates are to satisfy all eligibility criteria. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.
- 8. The posts of Senior Resident will be governed by CCS (Temporary Service) Rules.
- Qualifications and experiences as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee with prior approval of the Competent Authority. The experience will be counted up to the date of publishing this notification in the Institute website.

# 10. Application Procedure: -

- i. Eligible candidates are required to fill up the Online application along with relevant documents, within 15 days from the date of Publication of the Advertisement in the website & News Papers.
- 11. **Mode of Selection**: Based on the online Applications and further scrutiny, the Interview will be conducted in online mode after verifying the application and requisite documents of the candidates. The link will be shared prior to the interview to the eligible short listed candidates only. The selection of the candidates will be based on their performance in the online walk-in-interview only.
- 12. The merit list (selected and waiting list) for all categories i.e. UR / EWS / OBC / SC / ST shall be prepared on the basis of combined marks of written test and personal interview or only Personal Interview.

# 13. Selection Procedure: -

- i) The candidate can apply for more than one post out of enlisted Departments.
- ii) The merit list for all categories i.e. UR / EWS / OBC / SC / ST (selected and waiting list) shall be prepared on the basis of online personal interview.
- iii) Selected candidates will have to report for document verification following which the offers of appointment will be issued to the successful candidates subject to verification of their documents and found in order.
- iv) Any vacancy arising because of non-joining of the selected candidates in this selection or on resignation of candidates selected; the post will be offered to the candidates from waiting list according to their merit list. All applicants must provide phone numbers and e-mail for faster communication.
