



Admission to PDF Programme

An Act of Parliament in 1956 established the All India Institute of Medical Sciences (AIIMS) as an autonomous institution of national importance and defined its objectives and functions. By virtue of this Act, the Institute grants its own medical degrees and other academic distinctions. The degrees granted by the Institute under the All India Institute of Medical Sciences Act are recognized medical qualifications for the purpose of the Indian Medical Council Act and notwithstanding anything contained therein, are deemed to be included in the first schedule of that Act, entitling the holders to the same privileges as those attached to the equivalent awards from the recognized Universities of India.

Online applications with complete bio-data in the prescribed format, as available on the website – <https://www.aiimsbhubaneswar.edu.in> are invited from Indian Citizens for the admission to the Post-Doctoral Fellowship (PDF) programme for a maximum tenure period of 01(one) year at the AIIMS, Bhubaneswar. Candidates who are fulfilling all eligibility criteria as mentioned below may apply through online as per the prescribed format as available through online mode. Candidates who are working in Government Sector may intimate to their employer about their submission of application. However, they will submit NOC at the time of Personal Interview. Late and incomplete applications will not be considered.

4. Emoluments

Rs. 67,700/- as per 7th CPC, Level -11 of the Pay Matrix + NPA plus other usual Allowances as admissible under rules (Rs. 18,750 + 6600(Grade Pay) + NPA plus other usual Allowances as admissible under rules).

5. Leave

6. Internal Assessment

6 monthly internal Assessment or as decided by the AIIMS, Bhubaneswar.

7. Exit Examination

To be decided by AIIMS, Bhubaneswar.

8. Selection procedure

- a) The candidate can apply for more than one post out of the enlisted Departments separately but, they have to apply separately for different posts.
- b) Written / Viva-voice will be conducted if the number of candidates are more. However, there will be no written test for the post against which less number of applications are received than the vacancies. Director, AIIMS, Bhubaneswar will have the discretion to decide for which post written examination to be conducted and for which post there will be no written examination. The decision there of will be final.
- c) The merit list (selected and waiting list) will be prepared on the basis of combined marks of written test and personal interview or only Personal Interview.
- d) Any vacancy arising because of non-joining by selected candidates in this selection or by resignation of candidates, post will be offered to the candidates from waiting list according to the merit panel. All applicants must provide latest mobile numbers and e-mail for timely communication.
- e) For qualification /Reservation /Selection Procedure/Emolument/dates for Interview / counselling and other latest details, candidates are advised to visit AIIMS, Bhubaneswar website regularly.
- f) After filling of available posts of all remaining candidates shall be kept in the waiting list. They must leave two latest phone numbers and email with Academic Section for faster communication.
- g) Prior experience (research or clinical) in PDF in Critical Care Medicine / Palliative Care Medicine / Minimal Access Surgery and PDCC in Diagnostic Neuro Imaging as applicable will be given preference in selection process of upto 5 marks as decided by the committee.
- h) Selected Candidate will be expected to stay in Institute Campus if offered residential accommodation.
- i) Candidates working in Govt. / Semi-Govt., PSU should apply through proper channel only. The in-services candidates will not be permitted for examination / interview, without "No Objection Certificate" from the employer. In this connection, it is mentioned that as per the terms and conditions of Senior Residency Scheme that their engagement is to be regulated as per the CCS (Temporary Service Rules). As per rule 1(3) of the CCS (TSR) that these rules shall apply to all persons who hold a Civil Post including all civilians paid from defence service estimate under the Govt. of India, and who are under the rule making control of President, but who don't hold a lien or suspended lien on any post under the Govt. of India or State Govt.

9. Application Procedure

- a) The online application will be available at www.aiimsbhubaneswar.nic.in on **08-03-2022 (10.00 A.M)**. Candidates who are fulfilling the eligibility criteria can apply through online mode only.
- b) Director AIIMS, Bhubaneswar reserves the right to cancel the advertisement at any point of time without assigning any reason there of or fill up less/more number of posts as advertised depending upon the Institutional requirement.
- c) The original certificate i.e. MBBS degree certificate, Internship Completion Certificate, Qualifying degree (MBBS/MD/MS/DNB/DM/MCh) Medical registration Certificate, Date of Birth Certificate, Caste Certificate etc. of the candidates who are selected for the post of PDF will be verified. If any candidate, who joins the post and leaves/ resigns/ is terminated before the completion of the tenure, it may be done by giving one month's prior notice by either side as per the rules or by depositing pay and allowance in lieu thereof with the Institute for the period of which notice fall short of one month or so.

10. Terms & Conditions

- a) Canvassing information of any kind will lead to disqualification, incomplete applications will not be considered and will be REJECTED. No interim correspondence shall be entertained.
- b) The prescribed qualification is minimum and merely possessing the same does not entitle any candidate for selection.
- c) The appointees shall be granted leave in accordance with the instructions issued by the Government of India from time to time.

- d) Private practice of any type is strictly prohibited.
- e) He / She may work in shifts and can be posted at any place in the Institute as per the discrimination of the MS/Dean/Director.
- f) He/ She is expected to abide by the rules of conduct and discipline as applicable to the Institute employees.
- g) The candidate should not have been convicted by any Court of Law.
- h) In case, any information given or declaration by the candidate is found to be false or if the candidate has wilfully suppressed any information relevant to this appointment, he/she will be liable to be removed from the service and action will be taken as deemed fit by the Competent Authority.
- i) The decision of the Competent Authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- j) The Competent Authority reserves the right of any amendment, cancellation and changes to this Advertisement as a whole or in part without assigning any reason thereof.
- k) All disputes will be subject to jurisdictions of High Court, Cuttack (Odisha).
- l) Candidates working in Govt. / Semi-Govt., PSU should apply through proper channel only. Such candidate will not be permitted for examination / Interview, without "No Objection Certificate" from the employer.
