Subject: - Grant of Institute Research Project for the financial year 2017-18

Dear Colleagues,

The Annual Institute Research Grant (IRG) for regular faculty members of AIIMS, Bhubaneswar will be sanctioned for a period of 1 year (may be extended for another year on a case to case basis). In this connection, the Research Cell invites **concept proposals** for consideration for **the financial year 2017-18**.

The projects would be funded on competitive basis in consonance with the conditions outlined in the guideline approved by the competent authority (**Guidelines annexed**). Only one project per investigator is permissible in each financial year. **The funding is for consumables only, up to a maximum of Rs 3 lakhs**. Those investigators who have been funded any Intramural Project earlier can only apply if their previous project has been completed & its final report submitted to the Research Cell.

The Concept proposals can be submitted to Research cell **till 07th March 2017**. No proposals will be accepted after 07th March by the Research Cell. Investigators should submit the proposals both in **hard copy and soft copy through email (researchcellaiims@gmail.com)**

Kindly refrain from submitting 'Clinical Trial' proposals as they require DCGI clearance and also compensation to be paid in the event of serious adverse reaction. The budget allocation will have no provision for providing compensation. Only new projects will be accepted, intramural project proposals (non-funded) that have previously been submitted in the research cell should not be submitted again. Kindly avoid submitting duplicate projects which have already been submitted to other funding agencies.

ANNEXURE-1

GUIDELINE FOR Concept proposal under INTRAMURAL RESEARCH AT AIIMS. BHUBANESWAR

- Regular faculty members of AIIMS Bhubaneswar are entitled to funding of their intramural projects from the Institute Research Grant (IRG). However, the grant is primarily meant for Assistant and Associate Professors of the institute.
- Only one project per investigator is permissible in a financial year. The duration of the project should normally be for 12 months, extendable to 24 months only on case to case basis. Maximum budget allowable for intramural projects would be Rs 3 lakhs.
- As limited funds are available, concept proposals submitted for IRG will be peer reviewed. The Principal investigators of the selected proposals will be asked to submit the full proposal.

Format for Concept Proposal (Total should not exceed 2 pages)

Concept proposal need to be prepared with the following sub headings

1. Title of the project
2. Introduction
3. Novelty
4. Applicability
5. Objectives
6. Description of the project: This will include methodology, feasibility, Expected outcome, budget, etc.
7. Expected impact of advancement/ knowledge generated
